The bizSAFE programme is administered by the Ministry of Manpower (MOM) and Workplace Safety & Health Council (WSHC) and it recognizes Small Medium Enterprises (SMEs) for their efforts in managing safety and health hazards in their workplace / worksite. To ensure compliance to the Workplace Safety and Health Act (WSHA), **many established corporations have placed bizSAFE certification as a supplying, tendering and sub-contracting requirement. Thus, sub contractors, suppliers and tenderers having bizSAFE certification will have a competitive edge over those who do not.** To attain bizSAFE Level 2 certification, the company must nominate a Risk Management (RM) Champion to attend a bizSAFE Level 2 (WSQ Develop a Risk Management Implementation Plan). The RM Champion will then be able to chart out the RM Implementation Plan for the company. The company will be upgraded to bizSAFE Level 2 after the RM Champion completes the course.

**Target Participants** : Management level, Workplace Safety and Health (WSH) personnel, engineers and supervisors with workplace literacy and numeracy Level 5 under Employability Skills System (ESS) or equivalent

1. Verify the Expectations of a Risk Management Champion / Leader.
2. Form a Risk Management Team.
3. Establish Hazard identification Methodologies.
4. Establish Risk Assessment / Risk Control Methodologies.
5. Develop and present a Workplace Risk Management Plan.
6. Communicate the Identified Hazards, Risk Evaluated and Implemented Risk Control Measures.

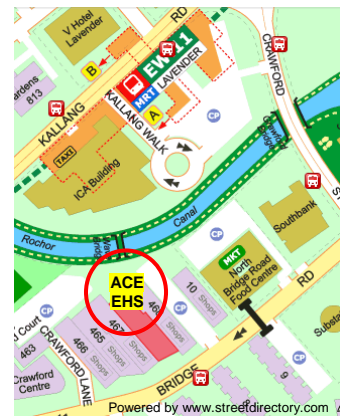
